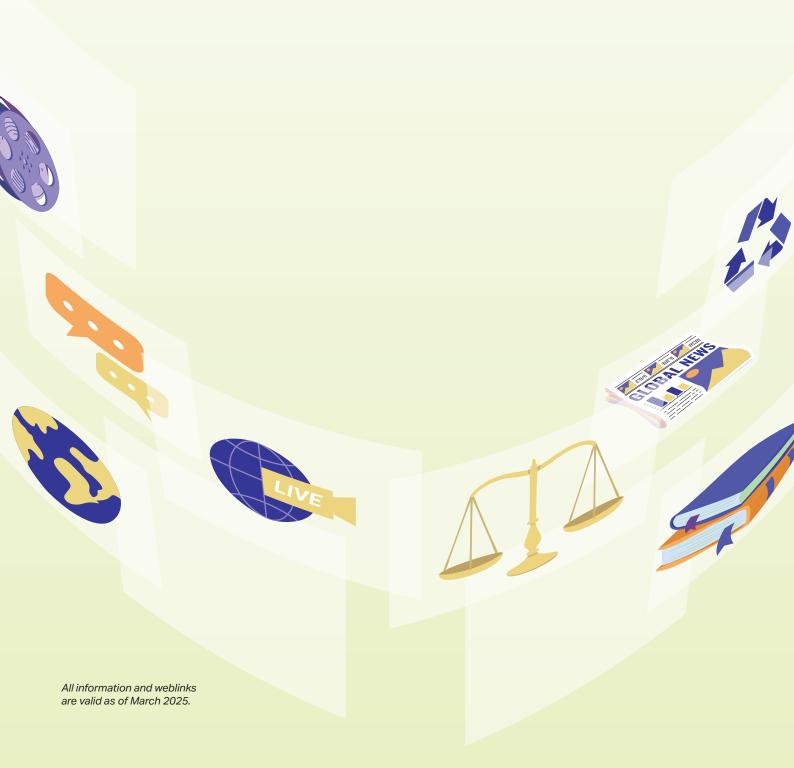



# **7/// Generative Al**

Generative artificial intelligence (GenAl) is taking the world by storm, and for good reason. It has gone mainstream and could revolutionise society and the economy as we know it. This technology has caused both excitement and fear about the future. 72% of Singaporeans surveyed are excited to use GenAl at work, but 51% cited worries about jobs.

Many people are excited because GenAl can create <u>new content</u>, including code, essays, images, social media posts, and videos. <u>ChatGPT</u> garnered <u>100</u> <u>million users</u> in just two months after its launch. The possibilities seem limitless!

With advancements in the technology, it is increasingly difficult to distinguish between <a href="https://www.numan.com/human.

Pessimists predict job disruption, increase wealth inequality, loss of privacy, and diminishing human intelligence. Critics say that GenAl lacks creativity and is encroaching on creativity. IMDA's Al Verify Foundation identifies six risks, including mistakes and hallucinations, privacy and confidentiality, disinformation and cyber-threats, copyright challenges, and embedded bias.

GenAl tools like ChatGPT have also led to global discussions about their capabilities, potential,

and risks. In the area of intellectual property, Algenerated works raise questions about <u>authorship</u>, <u>inventorship</u>, <u>and infringement</u>. Key <u>issues</u> include whether using Al-generated works ("outputs") and using copyrighted material to train generative Almodels ("inputs") constitute <u>copyright</u> infringement.

Additionally, the <u>environmental impact</u> of GenAl is a growing concern. Training Al models requires significant energy, leading to increased carbon emissions. This has prompted calls for more <u>sustainable development of Al</u>. Singapore is advancing sustainable Al practices through <u>Green Al</u> to help reduce Al's carbon footprint.

GenAl is in its infancy and its <u>implications</u> are not fully known. Some experts fear that it could be used for <u>malicious</u> exploitation. Nevertheless, it has great potential to empower individuals and organisations. When used in a safe and responsible manner, this technology can unlock tremendous opportunities that transform many aspects of modern life.

# The power and promises of generative Al

# GenAl could revolutionise the way many jobs are performed such as sales and marketing, customer operations, and software development.

Not only could it boost productivity, but it could also raise global GDP by 7% and increase productivity growth by 1.5 percentage points over a 10-year period, according to <u>Goldman Sachs Research</u>.

But perhaps the most exciting thing about this technology is the way it promotes divergent thinking and <u>augments human</u> <u>creativity</u>. By challenging expertise bias and helping us create unimaginable solutions, it opens up a whole new world of innovation.

# Generative AI will accelerate innovation and <u>democratise AI</u>.

GenAl can unlock human creativity and potential as well as <u>transform</u> industries and increase innovation. Such tools, together with low-code software that does not require extensive coding, are <u>accelerating innovation</u> in organisations.

Programmes such as DALL-E 2 could democratise Al by putting it into the hands of every person and every organisation. ChatGPT and other similar programmes are infiltrating workplaces. Workers are using GenAl tools to do their jobs better and boost output.

A great number of Singaporean employees (81%) would delegate as much work as possible to AI to lessen their workload. Most Singaporeans are comfortable using AI for analytical work (87%), administrative tasks (85%), and even creative work (81%).

# The perils and challenges of generative Al

# Generative AI could cause major disruption for the labour market.

Advances in Al could expose some 300 million jobs worldwide to automation. In the U.S., two thirds of occupations could be partially automated, with a quarter of their workload replaced. However, most jobs and industries are likely to be complemented rather than replaced by Al.

While it's true that GenAl will create many new jobs, it's likely that many existing jobs will be altered, from entry-level positions to those at <u>professional</u> levels, including the C-suite and middle managers. Workers need to start using Al now or <u>risk being left behind</u>.

GenAl tools such as ChatGPT and Midjourney are threatening to disrupt the world of <u>content creation</u>, impacting on marketing, software, design, entertainment, and interpersonal communications.

# Critics argue that GenAl may lead to the demise of human creativity.

With GenAl changing the nature of creativity, there is growing concern <u>among artists and critics</u> that it could spell the end of human creativity and originality.

While it might not entirely replace human ingenuity, GenAl has demonstrated the ability to <u>produce "a hit song"</u> in a fraction of the time.

Reliance on earning technologies that can visualise and conceptualise for us may lead to a <u>decline in primary artistic skills</u>, such as writing, drawing or painting. These skills typically require a deep understanding, continuous practice, and the development of expertise over time. While it democratises the artistic practice and it seems that <u>anyone can be an artist now</u>, is it impending doom for human creativity? As the emphasis shifts away from honing these skills and towards relying on technology, the risk of losing the ability to create without GenAl tools looms large.

### The question remains: Are we experiencing a revolution in work?

# Generative AI will change our daily lives for the better.

GenAl will free people up for more creative and intellectually fulfilling activities, leading more <u>human-centric lives</u>. It could, for example, deliver <u>personalised</u> learning content for students and provide real-time feedback fostering their growth.

It could transform healthcare, by providing tailored treatment plans as well as making healthcare delivery more efficient and equitable. Other possible uses could be a medical triage service or an application that provides plain English answers to patients' questions.

Individuals who need help with everyday stressors, such as issues with time management, personal life, or economic uncertainty, can use Al chatbots to point them to on-demand resources. Companies are using Al-powered mental health tools to help workers manage their stress and burnout.

No, Work Will Only See Incremental Changes.


### **Generative AI could hurt society.**

GenAl could cause <u>problems in society</u> if left unchecked. It could have key consequences on our public health, democracy, economy, and infrastructure. Other risks include its proneness to "<u>hallucinations</u>" that fabricate information entirely; and being used to create <u>misinformation</u> or <u>disinformation</u> making <u>social media</u> more damaging. Al could also be used by students to <u>problems</u> in societycheat.

Al tools are increasingly used to support people's health needs, including providing therapy. But the World Health Organization urges caution in using Al generated large language model (LLM) tools to protect human well-being, safety, and preserve public health. When the risks of LLMs are not fully examined, it could lead to errors by healthcare workers and cause harms to patients.

It could also <u>harm</u> our mental health due to perpetuating biases relating to <u>race</u>, <u>gender</u>, nationality and age occurring in natural language processing computer programmes, which understand human language as it's written and spoken.


